EMPLOYMENT NOTICE

Applications are invited to fill up **01 post of Driver (General) purely on adhoc basis**, on the consolidated pay of **Rs. 25,500/-** per month i.e. minimum pay scale of the post of Driver, as per Government of Haryana letter No. 16/36/ 2016-3GS-II dated 03.11.2017 duly adopted by Hon'ble High Court vide letter No. 209 Spl.E.II/VII.B.3 (Hy.) dated 20.02.2019, for a period of six months or till regular appointments are made by the Hon'ble High Court of Punjab and Haryana, Chandigarh, whichever is earlier. The selection for the aforesaid post shall be made strictly in accordance with amended Rule 7 of the Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Service) Rules, 1997.

1. As per Rule 7 (ix) ibid, the candidate should possess following academic qualifications/ requirements:
 - (i) The candidate should be at least middle pass with Punjabi/Hindi as one of the subject.
 - (ii) He should possess a valid licence for L.T.V.
 - (iii) He should not have been convicted of any offence for negligent driving and should have a minimum of two years experience of driving a car.
2. No person shall be recruited to the service if he/she is less than 18 years or is more than 42 years of age as on 01.01.2024, provided that relaxation in upper age limit is admissible to the reserved categories as per instructions of the Govt. of Haryana issued from time to time.
3. The last date for receipt of the applications by post or by hand in the office of the undersigned i.e. The District and Sessions Judge, Rohtak is 29.04.2024 **upto 05:00 pm**. Delay on the part of the postal or other authorities shall be no ground for entertaining the applications received after due date. Applications received after due date shall not be entertained in any manner and shall be refused straightway, without any further correspondence. Applications received through email shall not be entertained in any manner.
4. Application Form can be downloaded from the website of District Courts Rohtak i.e. <https://rohtak.dcourts.gov.in/notice-category/recruitments/>. Candidates are advised to visit the website regularly after 29.04.2024, for updates related to further process of recruitment.
5. One latest passport size colored photograph must be affixed on the application form and self attested photocopies of the educational documents and certificates regarding category, experience etc. must be attached with the application form.
6. Incomplete applications or applications received without requisite documents shall be rejected straightway without assigning any reason whatsoever. No correspondence, whatsoever shall be entertained in respect of incomplete applications or those which are refused by this office for receipt after expiry of the last date i.e. 29.04.2024.
7. The decision of the Selection Committee in all matters relating to acceptance or rejection of an application, eligibility/suitability of the applicants, mode/criteria for selection etc. shall be final and binding on the applicants.
8. Mode of selection: By conducting Driving test & interview (as per decision of Selection Committee) to check the practical knowledge of driving skill/rules/signs. Final selection shall be based on driving skill test and interview.
9. No TA/DA is admissible to any candidate appearing in the test(s) for the post mentioned above.
10. No separate call letters for the driving test shall be issued.
